Neuberger Berman Asset Management Ireland Limited ("NBAMIL") is the manufacturer of the Fund.

The Central Bank of Ireland (the "Central Bank") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this Key Information Document ("KID").

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended, and has been registered for sale in other EEA Member States. ## What is this product?

### Type:

This product is a UCITS fund.

### Objectives:

The Fund aims to increase the value of your shares over the long-term through investment in businesses that are connected with emerging (less developed) market countries and economies.

The Fund invests in a mixture of companies of different sizes, from different industries and does not focus on any specific country.

Investment selection is the result of fundamental research and analysis in an effort to identify companies that are believed to be undervalued, have strong corporate governance, are well managed and are financially strong. The investments are mainly in publicly traded shares or related instruments.

Investments may be sold when they reach a target price, when the company's business fails to perform or when other opportunities are more attractive. The Fund may not invest greater than 20% of its Net Asset Value ("NAV") non-MSCI Emerging Markets Index benchmark countries. The Fund may invest up to 10% of its NAV in China A Shares or in China B Shares.

China A Shares: Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai Stock Exchange and the Shenzhen Stock Exchange quoted in Chinese renminbi. A-shares are generally available for purchase by mainland citizens in China; foreign investment in China A Shares is subject to significant regulatory restrictions.

China B Shares: Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai Stock Exchange and the Shenzhen Stock Exchange quoted in a foreign currency such as US dollar. China B Shares are more widely available for purchase by foreign investors.

The Fund promotes environmental and social characteristics pursuant to Article 8 of SFDR.

This share class engages in currency hedging using derivative instruments to seek to limit the shareholder's currency risk by reducing the effect of foreign exchange rate fluctuations between the share class currency and the base currency of the Fund.

Income will be rolled up into the value of your investment.

### Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances, as described in the Prospectus in the section "Termination of Portfolios or Share Classes".

The shares may be exchanged for shares in another sub-fund of NBIF in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as an umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (the "Depositary") is appointed as the depositary of NBIF.

### Benchmark:

The Fund is actively managed and does not intend to track the benchmark, the MSCI EM Index (Total Return, Net of Tax, USD) which is included here for performance comparison purposes and because the Fund's investment policy restricts the extent to which the Fund's holdings may deviate from the benchmark, as described above. This deviation may be significant.

### Intended retail investor:

This Fund may be compatible with the needs of investors seeking a fund to deliver income and/or capital growth with an investment horizon of 4 years or more, as part of a diversified portfolio of investments. The Fund is a medium-high risk product and investors should consider this when deciding the mix of their portfolio of investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this Fund or to construct a diversified portfolio should seek professional investment advice. The Fund is unlikely to be compatible with the needs of those investors seeking a single investment, or to achieve a specified return by a particular date.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 4 years.

The summary risk indicator is a guide to the level of risk of this Fund compared to other products. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Fund as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of NBAMIL to pay you.

Beside the risks included in the risk indicator, other risks may affect the Fund's performance. The Fund does not include any protection from future market performance so you could lose some or all of your investment. If we are unable to pay you what is owed, you could lose your entire investment.

**Be aware of currency risk. You will receive payments in a different currency to the Fund's base currency, so the final return you will get depends on the exchange rate between the two currencies. However, the Fund will seek to mitigate this risk through the hedging described above.**

## Performance scenarios

The figures shown include all the costs of the Fund itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back. What you will get from this Fund depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the Fund/representative portfolio over the last 10 years.

The stress scenario shows what you might get back in extreme market circumstances, however, markets could develop very differently in the future.

## What happens if NBAMIL is unable to pay out?

Any such losses are not covered by any investor compensation or guarantee scheme.

## What are the costs?

The person advising on or selling you this Fund may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Fund and how well the Fund does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0% annual return). For the other holding period, we have assumed the Fund performs as shown in the moderate scenario and the investment is GBP 10,000.

## How long should I hold it and can I take money out early?

### Recommended holding period: 4 years

The Fund is designed to be held over the medium term and we recommend that you hold this investment for at least 4 years. Shares in the Fund can be bought or sold on a daily basis (save on certain bank holidays or public holidays and subject to certain restrictions described in the Prospectus).
