Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

USD A Accumulating Class (IE00BDZRXR46) Neuberger Berman Short Duration Emerging Market Debt Fund (the "Fund") a sub-fund of Neuberger Berman Investment Funds plc ("NBIF")

Neuberger Berman Asset Management Ireland Limited ("NBAMIL") is the manufacturer of the Fund.

The Central Bank of Ireland (the "**Central Bank**") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this Key Information Document ("**KID**").

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended, and has been registered for sale in other EEA Member States. What is this product?

Type:

This product is a UCITS fund.


Objectives:

The Fund aims to achieve a target average return of 3% over cash before fees over a market cycle (typically 3 years) by investing in a diversified selection of hard currency denominated (defined as USD, EUR, GBP, JPY, CHF) short duration sovereign and corporate bonds issued in emerging (less developed) market countries. Short duration securities have a shorter maturity (date on which a bond is repaid to the investor) and a lower duration (sensitivity to changes in interest rates). There can be no guarantee that the Fund will ultimately achieve its investment objective. The Fund is managed with a disciplined approach which begins with analysis of the market environment then with identifying asset classes with attractive valuations and liquidity. Whilst investments may be made in investment grade, high yield or unrated debt securities, the Fund intends to have a linear average credit rating of at least investment grade level. Investment grade securities are highly rated securities, generally those rated Baa3, BBB or above by one or more recognised rating agencies. High yield bonds generally have lower credit ratings, carry higher risks nonpayment but offer a higher income. Under normal market conditions, the Sub-Investment Managers (or the Manager where applicable) anticipate that the Fund's average interest duration will be within the range of +1.25 years and +2.75 years compared to the ICE BofA US 3-Month Treasury Bill Index (Total Return, USD).

The Fund promotes environmental and social characteristics pursuant to Article 8 of SFDR.

Income will be rolled up into the value of your investment.

What are the risks and what could I get in return? Risk Indicator



The risk indicator assumes you keep the product for 2 years.

The summary risk indicator is a guide to the level of risk of this Fund compared to other products. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances, as described in the Prospectus in the section "Termination of Portfolios or Share Classes".

The shares may be exchanged for shares in another sub-fund of NBIF in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as an umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (the "**Depositary**") is appointed as the depositary of NBIF.

You can obtain copies of the Prospectus and the latest reports and accounts for NBIF free of charge in English, German, French, Italian and Spanish, along with the latest published prices of shares and other information on the Fund, free of charge from Brown Brothers Harriman Fund Administration Services (Ireland) Limited (the "Administrator"), 30 Herbert Street, Dublin 2, Ireland.

Benchmark:

The Fund is actively managed and it is not constrained by the benchmark, the ICE BofA US 3-Month Treasury Bill Index (Total Return, USD) which is used for performance comparison purposes only. While the Fund may acquire securities which are components of the benchmark, it will not do so because of their inclusion in the benchmark.

Intended retail investor:

This Fund may be compatible with the needs of investors seeking a fund to deliver income and/or capital growth with an investment horizon of 2 years or more, as part of a diversified portfolio of investments. The Fund is a low risk product and investors should consider this when deciding the mix of their portfolio of investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this Fund or to construct a diversified portfolio should seek professional investment advice. The Fund is unlikely to be compatible with the needs of those investors seeking a single investment, or to achieve a specified return by a particular date.

We have classified this Fund as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of NBAMIL to pay you.

The Fund does not include any protection from future market performance so you could lose some or all of your investment. If we are unable to pay you what is owed, you could lose your entire investment.

Performance scenarios

What happens if NBAMIL is unable to pay out?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Fund and how well the Fund does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0% annual return). For the other holding period, we have assumed the Fund performs as shown in the moderate scenario and the investment is USD 10,000.
