Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

EUR I3 Accumulating Class (IE000QXNM1Z5) Neuberger Berman US Small Cap Intrinsic Value Fund (the "Fund") a sub-fund of Neuberger Berman Investment Funds plc ("NBIF")

Neuberger Berman Asset Management Ireland Limited ("NBAMIL") is the manufacturer of the Fund.

The Central Bank of Ireland (the "**Central Bank**") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this Key Information Document ("**KID**").

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended, and has been registered for sale in other EEA Member States. What is this product?

Type:

This product is a UCITS fund.

Objectives:

The Fund aims to increase the value of your shares through investment primarily in equity securities issued by small-capitalisation US companies.

These companies are typically valued at less than USD5 billion at the time of purchase or companies which are typically within the universe of the Russell 2000 Value Index (Total Return, Net of Tax, USD) ("**Benchmark**") and will be publicly traded US or foreign companies that conduct most of their business or are headquartered in the US.

The Fund aims to identify companies that the Sub-Investment Manager believe are selling at a material discount to their intrinsic value (i.e. its inherent worth, as distinct from its current market price) where a catalyst could cause the value of the company to increase. Such catalysts may include:

- Personnel/financial restructuring
- Management/organisational structure changes
- Share repurchases asset sales
- Any future business prospect which is believed to result in longterm growth of the company


The Fund may also invest up to 20% of its Net Asset Value in equity securities issued by US and non-US (including emerging (less developed) market countries) mid capitalisation companies (those between USD5 billion and USD20 billion at the time of purchase).

The Fund promotes environmental and social characteristics pursuant to Article 8 of SFDR.

This share class engages in currency hedging using derivative instruments to seek to limit the shareholder's currency risk by reducing the effect of foreign exchange rate fluctuations between the share class currency and the base currency of the Fund.

Income will be rolled up into the value of your investment.

What are the risks and what could I get in return? Risk Indicator



The risk indicator assumes you keep the product for 4 years.

The summary risk indicator is a guide to the level of risk of this Fund compared to other products. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances, as described in the Prospectus in the section "Termination of Portfolios or Share Classes".

The shares may be exchanged for shares in another sub-fund of NBIF in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as an umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (the "**Depositary**") is appointed as the depositary of NBIF.

You can obtain copies of the Prospectus and the latest reports and accounts for NBIF free of charge in English, German, French, Italian and Spanish, along with the latest published prices of shares and other information on the Fund, free of charge from Brown Brothers Harriman Fund Administration Services (Ireland) Limited (the "Administrator"), 30 Herbert Street, Dublin 2, Ireland.

Benchmark:

The Fund is actively managed and does not intend to track the Benchmark, the Russell 2000 Value Index (Total Return, Net of Tax, USD) which is used for performance comparison purposes and used as a universe from which to select securities. The Fund may not hold all or many of the Benchmark's components.

Intended retail investor:

This Fund may be compatible with the needs of investors seeking a fund to deliver income and/or capital growth with an investment horizon of 4 years or more, as part of a diversified portfolio of investments. The Fund is a medium-high risk product and investors should consider this when deciding the mix of their portfolio of investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this Fund or to construct a diversified portfolio should seek professional investment advice. The Fund is unlikely to be compatible with the needs of those investors seeking a single investment, or to achieve a specified return by a particular date.

We have classified this Fund as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of NBAMIL to pay you.

Beside the risks included in the risk indicator, other risks may affect the Fund's performance. Please refer to the Fund Prospectus and/or supplement at www.nb.com/en/gb/legal-documents. The Fund does not include any protection from future market performance so you could lose some or all of your investment. If we are unable to pay you what is owed, you could lose your entire investment.

Be aware of currency risk. You will receive payments in a different currency to the Fund's base currency, so the final return you will get depends on the exchange rate between the two currencies. However, the Fund will seek to mitigate this risk through the hedging described above. Performance scenarios

What happens if NBAMIL is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Fund and how well the Fund does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0% annual return). For the other holding period, we have assumed the Fund performs as shown in the moderate scenario and the investment is EUR 10,000.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years
