

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

GBP I2 Accumulating Class (IE00BD5BKG45) Neuberger Berman Uncorrelated Strategies Fund (the "Fund") a sub-fund of Neuberger Berman Investment Funds plc ("NBIF")

Neuberger Berman Asset Management Ireland Limited ("NBAMIL") is the manufacturer of the Fund.

The Central Bank of Ireland (the "Central Bank") is responsible for supervising NBAMIL, which is part of the Neuberger Berman Group, in relation to this Key Information Document ("KID").

The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended, and has been registered for sale in other EEA Member States. What is this product?

Type:

This product is a UCITS fund.

Objectives:

The Fund aims to achieve a target average return of 5% over the ICE BofA US Dollar 3-Month Deposit Offered Rate Constant Maturity Index (Total Return, USD) ("Benchmark") after Portfolio Costs (as defined in the Supplement) over a market cycle (typically 3 years) from a diversified portfolio of uncorrelated investment strategies. Correlation is the relationship or connection between different investments. The Fund allocates assets to multiple investment advisors that employ a variety of investment strategies which may include: (i) trend following; (ii) short term future trading; (iii) global macro investing, (iv) quantitative equity market neutral, (v) discretionary equity market neutral, (vi) statistical arbitrage, (vii) options arbitrage, (viii) insurance / reinsurance.

There can be no guarantee that the Fund will ultimately achieve its investment objective and capital invested is at risk.

Advisors are selected with the goal of building a portfolio of strategies which have low correlation to global equity and global fixed income markets over a full investment cycle. No more than 50% of the Fund's Net Asset Value ("NAV") will be allocated to one strategy and no more than 30% of the Fund's NAV will be allocated to one advisor at any one time. Although the Fund concentrates its investments in the US and other Organisation for Economic Co-operation and Development countries it may also invest in emerging (less developed) market countries.

The Fund may employ strategies that use a large number of financial derivative instruments that exaggerate potential returns or potential losses. As a result, the Fund may hold a significant proportion of its NAV in cash or cash equivalents to meet its obligations associated with these instruments.

The Fund does not apply the ESG Policy and the Sub-Investment Manager deems Sustainability Risks not to be relevant for the Fund's investment strategy.

This share class engages in currency hedging using derivative instruments to seek to limit the shareholder's currency risk by reducing the effect of foreign exchange rate fluctuations between the share class currency and the base currency of the Fund.

Income will be rolled up into the value of your investment.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances, as described in the Prospectus in the section "Termination of Portfolios or Share Classes".

The shares may be exchanged for shares in another sub-fund of NBIF in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as an umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (the "Depositary") is appointed as the depositary of NBIF.

Benchmark:

The Fund is actively managed and it is not constrained by the benchmark, the ICE BofA US Dollar 3-Month Deposit Offered Rate Constant Maturity Index (Total Return, USD) which is used for performance comparison purposes only. While the Fund may acquire securities which are components of the Benchmark, it will not do so because of their inclusion in the Benchmark.

Intended retail investor:

This Fund may be compatible with the needs of investors seeking a fund to deliver income and/or capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments. The Fund is a medium-low risk product and investors should consider this when deciding the mix of their portfolio of investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this Fund or to construct a diversified portfolio should seek professional investment advice. The Fund is unlikely to be compatible with the needs of those investors seeking a single investment, or to achieve a specified return by a particular date.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this Fund compared to other products. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Fund as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of NBAMIL to pay you.

Beside the risks included in the risk indicator, other risks may affect the Fund's performance. Please refer to the Fund Prospectus and/or supplement at www.nb.com/en/gb/legal-documents. The Fund does not include any protection from future market performance so you could lose some or all of your investment. If we are unable to pay you what is owed, you could lose your entire investment.

Be aware of currency risk. You will receive payments in a different currency to the Fund's base currency, so the final return you will get depends on the exchange rate between the two currencies. However, the Fund will seek to mitigate this risk through the hedging described above.

Performance scenarios

The figures shown include all the costs of the Fund itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back. What you will get from this Fund depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the Fund/representative portfolio over the last 10 years.

The stress scenario shows what you might get back in extreme market circumstances, however, markets could develop very differently in the future.

What happens if NBAMIL is unable to pay out?

Investors may face financial losses as a result of the default of the Fund, NBIF, NBAMIL or any of the service providers appointed to the Fund, including the Sub-Investment Managers (or their affiliates), the Administrator, the Depositary, or a trading counterparty. Any such losses are not covered by any investor compensation or guarantee scheme.

What are the costs?

The person advising on or selling you this Fund may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Fund and how well the Fund does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0% annual return). For the other holding period, we have assumed the Fund performs as shown in the moderate scenario and the investment is GBP 10,000.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 4.9% before costs and 1.4% after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The Fund is designed to be held over the medium term and we recommend that you hold this investment for at least 3 years. Shares in the Fund can be bought or sold on a daily basis (save on certain bank holidays or public holidays and subject to certain restrictions described in the Prospectus).
