Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.


Objectives

Product objectives The Fund's objective is to achieve capital appreciation. **Investment approach** The Fund will primarily invest in equities of companies with principal offices or significant business activities in the People's Republic of China and Hong Kong, the securities of which are quoted securities listed or traded on Recognised Markets worldwide. The investment strategy of the Fund is to adopt a fundamental stock-picking approach by investing in small, medium and large companies which have re-rating investing in small, medium and large companies which have re-rating potential. This is a bottom-up analysis of a company. The Investment Manager will focus on the earnings outlook, profitability trend, balance sheet strength and management quality of a company. The key focus on the stock picking process will be financial ratios analysis and peers comparison. The Sub-Fund is permitted to invest up to 100% of its NAV in China A shares which are listed on the Shanghai Stock Exchange using the Shanghai-Hong Kong Stock Connect or the Shenzhen Stock Exchange using the Shenzhen Hong Kong Stock Connect. Alternatively, the Sub-Fund may gain indirect exposure to China A shares via participatory notes issued by Qualified Foreign Institutional Investors and via investment in other collective Foreign Institutional Investors and via investment in other collective investment schemes which primarily invest in China A shares.

Benchmark The Fund's benchmark is the MSCI China All Shares Net Return USD and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Redemption policy Shares in the Fund Can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company,

Term The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.
