What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Objectives

Product objectives The Fund's objective is to achieve capital appreciation. **Investment approach** The Fund will primarily invest in equities of companies with principal offices or significant business activities in the People's Republic of China and Hong Kong, the securities of which are quoted securities listed or traded on Recognised Markets worldwide. The investment strategy of the Fund is to adopt a fundamental stock-picking approach by investing in small, medium and large companies which have re-rating potential. Alternatively, the Sub-Fund may gain indirect exposure to China A shares via participatory notes issued by Qualified Foreign Institutional Investors and via investment in other collective Foreign Institutional Investors and via investment in other collective investment schemes which primarily invest in China A shares.

Benchmark The Fund's benchmark is the MSCI China All Shares Net Return USD and may be used for comparative purposes only. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.
