## What is this product?

**Type** The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

### Objectives

**Product objectives** The Fund aims to achieve capital appreciation through investment in securities in the European Region, including the United Kingdom and Switzerland.

**Investment approach** The Fund will primarily invest in equities and equity-related securities of companies that primarily have their registered office in the European Region including the UK and Switzerland and which are listed or traded on Recognised Markets worldwide. Equity-related securities include convertible bonds issued by corporates with fixed and/or floating rates of interest and with investment grade ratings of Baa3 or above by Moody's or BBB- or above by Standard and Poor's or equivalent credit ratings. The Investment Manager seeks to invest in companies that score most attractively according to a proprietary quantitative equity screen based on fundamental analysis. Subjective analysis of these stocks is also applied before investment as a risk and quality control measure.

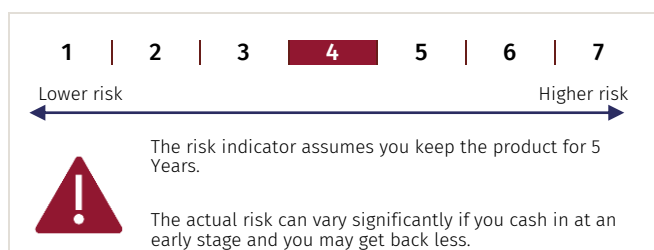
**Benchmark** The Fund's benchmark is the MSCI Europe Net Return EUR Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

**Redemption policy** Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company, however charges of this nature may be levied by third party nominees, distributors or intermediaries.

**Distribution policy** Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

### Performance Scenarios

**Derivatives policy** The Fund may use techniques and instruments for purposes of efficient portfolio management including reduction of risk or cost, or the generation of additional capital or income for the Fund, with a level of risk which is consistent with the risk profile of the Fund such as forward foreign currency exchange contracts, futures contracts, options, put and call options on securities, indices and currencies, and swap contracts. The use of these instruments may result in the Fund being leveraged. However, the total exposure of the Fund as a result of all positions held by it will not exceed its Net Asset Value.

**Intended retail investor** The Fund is suitable for investors seeking capital growth and income over a medium term with a high level of volatility.

**Term** The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

#### What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

#### Costs over time

#### How long should I hold it and can I take my money out early?

##### Recommended holding period: 5 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 Years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 3 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
