What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Objectives

Product objectives The investment objective of the Fund is to achieve mid-term capital appreciation, primarily through investment in quoted equities issued by companies with principal offices or significant business activities in Switzerland.

Investment approach The Fund invests at least two-thirds of its assets in equities and other equity-type securities issued by small and medium-sized companies listed on the SPI Extra TR index or that carry out the bulk of their business activities in Switzerland. Up to one-third of assets may be invested in equities of companies of any size worldwide. The Fund may invest up to 10% in convertible bonds of Swiss companies and up to 10% in collective investment schemes. The Fund may use derivatives for investment and efficient portfolio management purposes. Cash and cash equivalents may be held for ancillary purposes. The Fund uses a bottom-up, fundamental research approach to select stocks. It considers qualitative and quantitative criteria to assess innovation power, management quality, business model, company valuation, and macroeconomic risk parameters. ESG factors are integrated into the investment process through the use of a proprietary ESG score.

Benchmark The Fund's benchmark is the SPI Extra TR index, which tracks mid-cap and small-cap companies primarily listed in Switzerland. The Fund is actively managed and while at least two-thirds of its securities will be invested in stocks of the Index, the Sub-Investment Manager has discretion to invest in securities not included in the Index to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company,

however charges of this nature may be levied by third party nominees, distributors or intermediaries.

Distribution policy Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

Exchange policy Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information on how to switch.

Asset segregation The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

Derivatives policy The Fund may use the following derivatives for investment and/or efficient portfolio management purposes, with a level of risk which is consistent with the risk profile of the Fund: index and/or stock futures and options and FX contracts. Although the use of derivatives may give rise to leverage, any such leverage will not exceed the Net Asset Value of the Fund.

Intended retail investor The Fund is suitable for investors seeking capital growth over a medium term.

Term The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

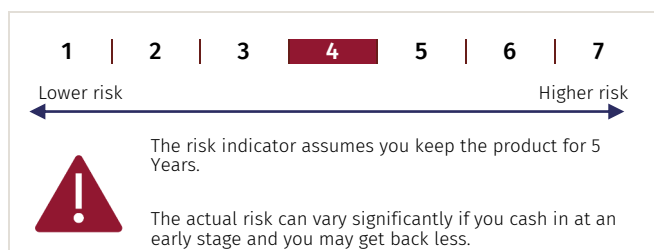

What are the risks and what could I get in return?

Risk Indicator

What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should the Fund default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- CHF 10 000 is invested.

How long should I hold it and can I take my money out early?

Recommended holding period: 5 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 Years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 2 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
