What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Product objectives The Fund's investment objective is to seek long-term appreciation through a combination of income and capital growth

Investment approach The Fund will invest in a diversified range of debt securities with a range of maturities (including inter alia notes, bills, bonds, commercial paper, certificates of deposit and floating rate notes) issued by governments, institutions and corporations primarily listed or traded on Recognised Markets worldwide. The Fund will invest primarily in euro-Recognised Markets worldwide. The Fund will invest primarily in eurodenominated securities but may invest up to 30% of its net assets in noneuro hard currency-denominated securities. The Fund will invest across a variety of geographical locations. The Fund will predominantly hold corporate bonds with investment grade ratings (Baa or above by Moody's or BBB or above by Standard and Poor's or equivalent credit ratings as determined by another credit rating agency or by the Sub-Investment Manager) but up to 30% of the Fund's net assets may be invested in lower quality securities. Up to 10% may be invested in unrated securities. The Fund focuses on the best investment opportunities in the investable universe, taking a systematic approach that combines systematic screening of hottom-un opportunities approach that combines systematic screening of bottom-up opportunities with top-down asset allocation themes.

Benchmark The Fund's benchmark is the BofA Merrill Lynch European Large Cap Corporate Bond Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment consequences. benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company, however charges of this nature may be levied by third party nominees, distributors as intermediation. distributors or intermediaries.

Term The Fund is open-ended and has no maturity date. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

In the worst case, however, you could lose your entire investment.

What are the costs?

Recommended holding period: 3 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 3 Years.
