What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Objectives

Product objectives The Fund's investment objective is to seek long-term appreciation through a combination of income and capital growth

Investment approach The Fund will invest in a diversified range of debt securities with a range of maturities (including inter alia notes, bills, bonds, commercial paper, certificates of deposit and floating rate notes) issued by governments, institutions and corporations primarily listed or traded on Recognised Markets worldwide. The Fund will invest primarily in euro-Recognised Markets worldwide. The Fund will invest primarily in euro-denominated securities but may invest up to 30% of its net assets in non-euro hard currency-denominated securities. The Fund will invest across a variety of geographical locations. The Fund will predominantly hold corporate bonds with investment grade ratings (Baa or above by Moody's or BBB or above by Standard and Poor's or equivalent credit ratings as determined by another credit rating agency or by the Sub-Investment Manager) but up to 30% of the Fund's net assets may be invested in lower quality securities. Up to 10% may be invested in unrated securities. The Fund focusses on the best investment opportunities in the investable universe, taking a systematic anproach that combines systematic screening of bottom-run opportunities approach that combines systematic screening of bottom-up opportunities with top-down asset allocation themes.

Benchmark The Fund's benchmark is the BofA Merrill Lynch European Large Cap Corporate Bond Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to advantage of specific investment comparison. benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund).

Distribution policy Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

Waystone Management Company (IE) is not entitled to terminate the product unilaterally.

How long should I hold it and can I take my money out early?

Recommended holding period: 3 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 3 Years.
