New Capital UCITS Fund Plc is authorised in Ireland and regulated by the Central Bank of Ireland. The management company of the Fund is Wystone Management Company (IE) Limited which is authorised in Ireland and regulated by the Central Bank of Ireland. The investment manager is EFG Asset Management (UK) Limited, which is authorised in the United Kingdom and regulated by the Financial Conduct Authority.

What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Objectives

Product objectives The investment objective of the Fund is to achieve capital appreciation through investment in a portfolio of equity securities.

Investment approach In order to achieve its investment objective, the Fund will primarily invest in equities of companies which have either their registered offices or conduct the majority of their business in Asia, the securities of which are listed or traded on Recognised Markets worldwide. The strategy of the Fund is to identify companies that are market share leaders or emerging leaders poised to capitalise on opportunities to expand the market or consolidate the particular industry in which the relevant company operates and, as such, the Fund will have a focus on growth stocks. The Fund may gain exposure of less than 20% of its Net Asset Value to China A shares by investing directly in China A shares, which are listed on the Shanghai Stock Exchange using the Shanghai Hong Kong Stock Connect, or the Shenzhen Stock Exchange using the Shenzhen Hong Kong Stock Connect, or by investing indirectly via participatory notes. The Fund may also invest in other collective investment schemes ("CIS") provided such investments are eligible for investment by UCITS and give exposure to investments in which the Fund may invest directly in accordance with the investment policy of the Fund. Investment in CIS shall not exceed in aggregate 10% of the Net Asset Value of the Fund

Benchmark The Fund's benchmark is the MSCI AC Asia ex Japan Net Total Return USD Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund).

Distribution policy Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

Exchange policy Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information on how to switch.

Asset segregation The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

SFDR Article 8

Derivatives The Fund will not invest in financial derivative instruments ("FDIs") for investment purposes. However, the Fund may use FDIs such as forward foreign currency exchange contracts for hedging purposes.

Intended retail investor The Fund is suitable for investors seeking capital growth over a long time horizon with a high level of volatility commensurate with a portfolio of Asian high growth companies.

Term The Fund has no maturity date.

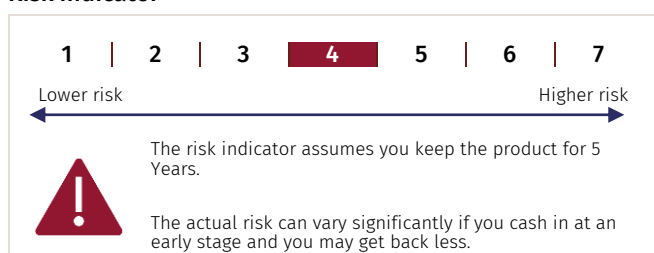

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

Equity risk: Equity prices fluctuate daily, based on many factors including general, economic, industry or company news.

Liquidity risk: In difficult market conditions, the Fund may not be able to sell a security for full value or at all. This could affect performance and could cause the Fund to defer or suspend redemptions of its shares.

Risks associated with investment via Stock Connect: Stock Connect is a securities trading and clearing-linked program with the aim of achieving mutual stock market access between Mainland China and Hong Kong, and enables the Fund to trade eligible China A shares listed on the Shanghai Stock Exchange or the Shenzhen Stock Exchange. Further information on the risks associated with investment via Stock Connect is set out in the Prospectus.

Volatility risk: The Fund may have greater volatility compared to broader market indices as a result of the Fund's focus on growth stocks.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do

not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

What happens if EFG Asset Management (UK) Limited is unable to pay out?

How long should I hold it and can I take my money out early?

Recommended holding period: 5 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 Years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 3 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
