## What is this product?

**Type** The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

### Objectives

**Product objectives** The Fund's objective is to deliver a consistent risk-adjusted return in all market environments over rolling 12-month periods.

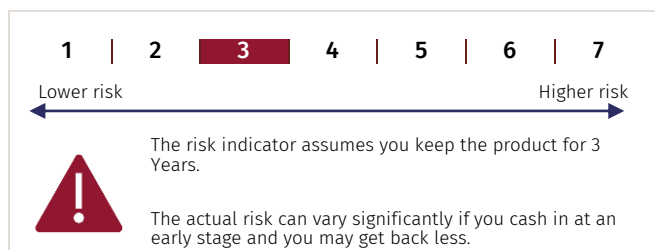
**Investment approach** The Fund will gain exposure to a diverse global allocation of asset classes and may invest directly or indirectly in sovereign and corporate bonds, equities and commodities, infrastructure and property. Indirect exposure to these asset classes will, where applicable, be generated through investing in collective investment schemes, including exchange-traded funds (index-tracking funds that can be traded on exchanges just like a stock). Where the Fund invests in other collective investment schemes, underlying managers are selected first based on macro or micro economic views and then filtered based on data analysis using proprietary tools and supplemented by interviews with key decision makers and operating and liquidity risk scoring. No direct investment shall be made in commodities, infrastructure or property. The Fund is permitted to invest less than 10% of its NAV in China A shares which are listed on the Shanghai Stock Exchange using the Shanghai-Hong Kong Stock Connect or the Shenzhen Stock Exchange using the Shenzhen-Hong Kong Stock Connect. The sovereign and corporate bonds in which the Fund may invest may have fixed or floating rates of interest. No credit rating requirements will apply to these instruments and the Fund may generate exposure of more than 30% of net assets in bonds which constitute below investment grade securities. There will be no restrictions on the investment type, geographical or economic sector to which the Fund is exposed. However, any exposure to emerging markets will not exceed 30% of the Fund's net assets and up to 10% of net assets may be exposed to Russia. The Sub-Fund may also invest in contingent convertible bonds.

**Benchmark** The Fund's benchmark is the ICE BofA SONIA 1-Month Constant Maturity Index plus a risk premium of 3 percentage points per annum and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

**Redemption policy** Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved.

## Performance Scenarios

Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company, however charges of this nature may be levied by third party nominees, distributors or intermediaries.

**Distribution policy** Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

**Exchange policy** Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information on how to switch.

**Asset segregation** The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

**Derivatives policy** The Fund may use derivatives for efficient portfolio management purposes only with a level of risk which is consistent with the risk profile of the Fund. Such instruments may include forward foreign exchange contracts index options and convertible securities. The leverage arising from the use of derivatives (including those embedded in any contingent convertible bonds) will not exceed the Net Asset Value of the Fund.

**Intended retail investor** This Fund is suitable for investors seeking a low to medium risk profile and a medium to long term investment (i.e. at least 3 to 5 years).

**Term** The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

#### What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

#### What are the costs?

#### Costs over time

#### How long should I hold it and can I take my money out early?

##### Recommended holding period: 3 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 3 Years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 3 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
