## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## What is this product?

**Type** The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

### Objectives

**Product objectives** The Fund's investment objective is principally to achieve an optimum total return.

**Investment approach** The Fund will primarily invest in equities and equity-related securities, such as warrants and rights, issued by companies which have either their registered offices or conduct the majority of their business in Japan or which, as holding companies, invest mainly in companies which have their registered office in Japan, as well as in other investments as permitted pursuant to the investment policy of the Fund and which may be listed or traded on Recognised Markets. Normally, at least two-thirds of the assets of the Fund shall be invested in equities and equity-related securities issued by companies which either have their registered offices or conduct the majority of their business in Japan, UCITS eligible open-ended and closed-ended collective investment schemes which invest in Japan equities, as well as derivatives and participatory notes on such investments. Up to one third of the assets may be invested in equities and equity-related securities issued by companies that do not conduct the majority of their business in Japan, as well as in investment-grade bonds, convertible bonds, convertible notes, warrant issues and notes denominated in freely convertible currencies, money market instruments, derivatives on such investments and units in collect investment schemes that do not invest in Japan equities, the issuers of which will be government or corporate borrowers. The Fund uses a combination of top-down macroeconomic view that determines the sector allocation and bottom-up stock-picking, that determines a company's financial strengths and weaknesses.

**Benchmark** The Fund's benchmark is the MSCI Japan Net Total Return Local Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

**Redemption policy** Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money

laundering procedures. Redemption fees will not be levied by the Company, however charges of this nature may be levied by third party nominees, distributors or intermediaries.

**Distribution policy** Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

**Exchange policy** Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information on how to switch.

**Asset segregation** The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

### SFDR Article 8

**Derivatives policy** The Fund may use techniques and instruments for investment and/or efficient portfolio management such as futures, options, forwards and swaps. The use of these instruments may result in the Fund being leveraged. However, the total exposure of the Fund as a result of all positions held by it will not exceed its Net Asset Value.

**Intended retail investor** The Fund is suitable for investors with a long-term horizon who are primarily seeking to achieve capital growth, who can accept larger fluctuations and a longer-lasting decline in the Net Asset Value of the Sub-Fund Shares and who are aware of the considerable risks an equity investment entails.

**Term** The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

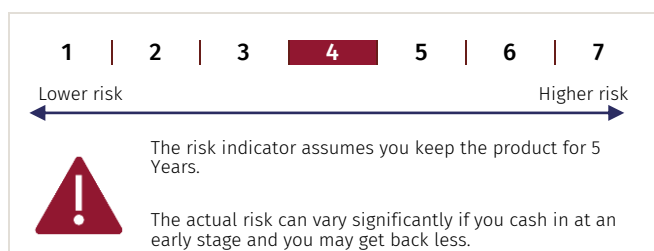

#### What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company of the Fund has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

#### Costs over time

#### How long should I hold it and can I take my money out early?

##### Recommended holding period: 5 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 Years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 3 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
