What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Product objectives The investment objective of the Fund is to generate a combination of income and capital growth.

Investment approach In order to achieve its investment objective, the Fund will gain exposure to a portfolio of global securities that are diversified by both region and sector, balanced primarily between bonds and equities. The Fund may also gain exposure directly or indirectly to equities, sovereign and corporate bonds, and may gain exposure indirectly, through investment in collective investment schemes, to alternative investments such as commodities, infrastructure and property. The asset classes and any exchange-traded financial derivatives in which the Fund may invest may be listed or traded on Recognised Markets in major financial markets worldwide. The Fund is permitted to invest less than 20% of its NAV in China A shares which are listed on the Shanghai Stock Exchange using the Shanghai-Hong Kong Stock Connect or the Shenzhen Stock Exchange using the Shenzhen-Hong Kong Stock Connect. The sovereign and corporate bonds in which the Fund may invest may have fixed or floating rates of interest. The Fund may have exposure of more than 15% of net assets in bonds which constitute below investment grade securities. However, such investment will not exceed 30% of net assets. No credit rating requirements will apply to the sovereign and corporate bonds in which the Fund may invest. The Fund may invest in certain types of convertible securities comprising Convertible and/ or Contingent Convertible Bonds up to 20% of the Net Asset Value of the Fund. The Fund may also investments are eligible for investment by UCITS and give exposure to investments in which the Fund may invest directly in accordance with the investment policy of the Fund. Investment in open-ended CIS and with the investment policy of the Fund. Investment in open-ended CIS and also in closed-ended CIS shall each be limited to 20% of the Net Asset Value

Benchmark The Fund's benchmark is the Medium Risk Composite Benchmark and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods,

Derivatives policy The Fund will not invest in financial derivative instruments ("FDIs") for investment purposes. However, the Fund may use FDIs such as forward foreign currency exchange contracts, futures contracts, options, index options, and convertible bonds (which are deemed to embed a derivative) for hedging purposes.

Intended retail investor The Fund is suitable for investors with a medium risk appetite and seeking to achieve moderate returns over a medium-term investment horizon (five to 10 years).

Term The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.
