### What is this product?

**Type** The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

### Objectives

Product objectives The Fund's objective is to achieve a high level of income as well as capital appreciation.

Investment approach The Fund will primarily invest in equities and equityrelated securities, specifically convertible bonds, of companies worldwide which are listed or traded on Recognised Markets worldwide. The investment which are listed or traded on Recognised Markets worldwide. The investment strategy of the Fund is to create a portfolio of global equities and equity-related securities that are diversified by both region and sector and are selected by the Investment Manager's stock-picking, proprietary "conviction" framework. The Fund may have an exposure to emerging markets and such exposure may exceed 20% (and may be up to 100%) of the Fund's net assets. The Fund is permitted to invest less than 30% of its NAV in China A shares which are listed on the Shanghai Stock Exchange using the Shanghai-Hong Kong Stock Connect or the Shenzhen Stock Exchange using the Shenzhen-Hong Kong Stock Connect. Alternatively, the Fund may gain indirect exposure to China A shares via participatory notes issued by Qualified Foreign Institutional Investors and via investment in other collective investment schemes which primarily invest in China A shares. No more than 10% of the schemes which primarily invest in China A shares. No more than 10% of the Net Asset Value of the Fund may be invested in the Russian market. With respect to Russia, the Fund will invest in equities listed on the Moscow Exchange.

Benchmark The Fund's benchmark is the MSCI AC World Net USD and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company,

The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

## Recommended holding period: 5 Years
