What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Objectives

Product objectives The Fund's objective is to achieve a combination of longterm capital and income returns.

Investment approach The Fund will invest in a diversified range of fixed or floating rate debt securities with a range of maturities (including non-bespoke notes, bills, bonds) issued by sovereigns, supranational entities, public local authorities, semi-public enterprises, institutions or corporations primarily listed or traded on Recognised Markets worldwide. The Fund will invest at least 70% of its net assets in debt securities issued by sovereigns, supranational entities and agencies and not more than 25% of its net assets in subordinated debt securities. The Fund will invest primarily in high-quality for a guarantee traded bands dependent on the primarily in high-quality in the primarity in high-quality for the primarity in high-quality. In subordinated debt securities. The Fund will invest primarily in high-quality government and government-related bonds denominated in USD (at least 66% in USD-denominated securities but may invest up to 33% of its NAV in non-USD currency denominated securities). Benchmark The Fund's benchmark is the ICE BofAML 1-10 Year US Treasury Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.
