## Purpose

## What is this product?

**Type** The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

### Objectives

**Product objectives** The Fund's objective is to achieve a combination of long-term capital and income returns.

**Investment approach** The Fund will invest in a diversified range of fixed or floating rate debt securities with a range of maturities (including non-bespoke notes, bills, bonds) issued by sovereigns, supranational entities, public local authorities, semi-public enterprises, institutions or corporations primarily listed or traded on Recognised Markets worldwide. The Fund will invest at least 70% of its net assets in debt securities issued by sovereigns, supranational entities and agencies and not more than 25% of its net assets in subordinated debt securities. The Fund will invest primarily in high-quality government and government-related bonds denominated in USD (at least 66% in USD-denominated securities but may invest up to 33% of its NAV in non-USD currency denominated securities). The Fund will not invest more than 10% of its Net Asset Value in debt securities with a credit rating below investment grade. The Fund will not invest more than 30% of its net assets in corporate bonds. The Fund may also invest up to 10% of its NAV in open-ended and closed-ended collective investment schemes (including exchange traded funds). The Fund will invest across a variety of geographical locations.

**Benchmark** The Fund's benchmark is the ICE BofAML 1-10 Year US Treasury Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

**Redemption policy** Shares in the Fund can be bought and sold daily (every Business Day of the Fund).

**Distribution policy** Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

**Exchange policy** Subject to the conditions set down in the Prospectus, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the Company. Please refer to the Prospectus for further information on how to switch.

**Asset segregation** The Fund is a sub-fund of the Company, an umbrella fund with segregated liability between sub-funds. You can find out more information about the umbrella fund in the Prospectus.

### SFDR Article 6

**Derivatives** The Fund will enter into financial derivative instruments for efficient portfolio management purposes including hedging. Such derivative instruments may include forward foreign exchange contracts, futures, options, interest rate swaps and credit default swaps.

**Intended retail investor** The Fund is suitable for investors, both private and institutional, that have a short-term investment horizon and wish to invest in a broadly diversified portfolio of bonds denominated in USD.

**Term** The Fund has no maturity date.

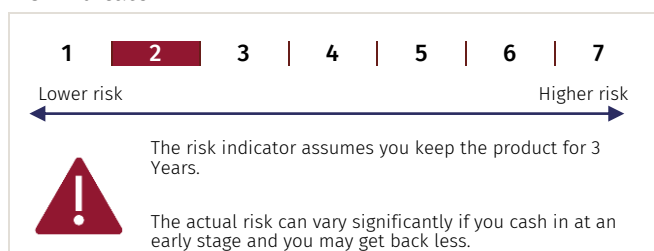

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity to pay you.

**Liquidity risk:** The risk that assets may not be saleable immediately at a price consistent with that observed for valuation purposes.

#### How long should I hold it and can I take my money out early?

##### Recommended holding period: 3 Years

This product is designed for longer term investments; you should be prepared to stay invested for at least 3 Years. Redemptions are possible on every working day; it will take 3 working days for you to be paid. The price per share for the day, based on the actual value of the Share Class, is set each day at 23:00 hours (Irish time).
