What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Objectives

Product objectives The Fund's objective is to seek long term appreciation through a combination of income and capital growth by investing in a portfolio of sub-investment grade debt instruments.

Investment approach The Fund will invest in high yield debt instruments (such as bills, bonds and notes) which may have a fixed or floating rate of interest and which will be rated Ba or below by Moody's or BB or below by Standard and Poor's. There will not be a minimal acceptable credit rating for Standard and Poor's. There will not be a minimal acceptable credit rating for any such debt instrument to be purchased or held by the Fund. The Fund will invest in such debt instruments issued by governments, institutions and corporations primarily listed or traded on Recognised Markets worldwide. There is no maturity limitation. Up to 15% of the Fund's Net Asset Value may be invested in unrated securities that are deemed to have an equivalent noninvestment grade credit rating by the Investment Manager. The Fund will invest in debt instruments of issuers located throughout the world, including emerging market countries. The Fund may also invest up to 15% of its Net Asset Value in Convertible and Perpetual Bonds in order to achieve its investment objective by generating income and capital growth from Asset Value in Convertible and Perpetual Bonds in order to achieve its investment objective by generating income and capital growth from investment in the instruments themselves or alternatively from the underlying of those instruments No more than 5% of the Net Asset Value of the Fund will be invested in warrants. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.
