What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Product objectives The investment objective of the Fund is to achieve capital appreciation through investment in a portfolio of equity securities

Investment approach The Fund will primarily invest in equities of companies which have either their registered offices or generate a significant portion of their business in emerging markets or which, as holding companies, invest mainly in companies that have their registered office in emerging markets, the securities of which are listed or traded on Recognised Markets worldwide. The Fund may gain exposure of less than 10% of its Net Asset Value to China A shares. The Fund may also invest in open-ended and closed-ended collective investment schemes (including exchange traded funds or "ETFs") provided such investments are eligible for investment by UCITS and give exposure to investments in which the Fund may invest directly in accordance with the above investment in exchange traded funds or "ETFs") with the above investment policy. Investment in collective investment schemes shall not exceed in aggregate 10% of the Net Asset Value of the Fund. Unlike open-ended collective investment schemes, investment in closed-ended collective investment schemes will only be made where such investment constitutes transferable securities for UCITS purposes.

Benchmark The Fund's benchmark is the MSCI Emerging Markets ex China Net Return USD Index and Solactive GBS Emerging Markets Ex China Custom Regions Index Net Total Return Net Return USD Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company,

Intended retail investor The Fund is suitable for investors seeking capital growth over a long time horizon with a high level of volatility commensurate with a portfolio of high growth companies in emerging markets.

Term The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. Waystone Management Company (IE) is not entitled to terminate the product unilaterally. The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

Recommended holding period: 5 Years
