## What is this product?

#### Type

The Product is a share of the Sub-fund Wellington Sterling Core Bond Plus Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

#### Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

## **Objectives**

The Fund seeks long-term total returns.

The Fund will be actively managed against the ICE BofA Merrill Lynch Sterling Broad Market Index (the "Index"), investing primarily in sterling-denominated fixed income debt securities. The Index is a measure of the total return of fixed income securities issued in sterling and includes sovereign and corporate issuance. The Investment Manager combines a base of sterling fixed income assets combined with a range of global fixed income and currency strategies (denominated in Sterling as well as other currencies) including global interest rates, investment grade corporate bonds, global high yield bonds or sovereign bonds. As the Fund has a sterling benchmark, the Investment Manager aims to generate returns by using the widest fixed income opportunity set in conjunction with a majority of sterling assets. The Fund will generally be diversified by country, currency, issuer and investment strategy, but may hold concentrated positions from time to time.

The Fund will invest, either directly or via derivatives, in bonds (fixed or floating rate) issued by government, agency, supranational or corporate issuers; mortgage and other asset-backed securities and currencies. The Fund's average credit quality is expected to be A3 by Moody's or A by Standard & Poor's or higher.

Derivatives may be used to hedge (manage) risk and for investment purposes (such as gaining exposure to a security).

The Index may be considered during portfolio construction and is used for performance comparison purposes. Fund securities may be components of the Index but are not expected to have similar weightings. The Investment Manager may limit the extent that currency and issuer weightings, as well as overall interest rate duration, differ from the Index but this should not be expected to limit the Fund's ability to achieve long-term total returns in excess of the Index.

The Fund will seek to support certain environmental and social characteristics and will abide by the following binding restrictions:

- The Fund will restrict its investment in sovereign issuers where fossil fuels make up more than two-thirds of exports to a maximum of 1.5% of the Fund's Net Asset Value.
- For investments made in corporate bonds, the Fund will not invest in issuers that the Investment Manager believes have the lowest environmental and social standards relative to their industry peers. The Fund excludes corporate issuers rated 5 for E or S Rating using a rating scale of 1-5, where 1 is the highest rating.

During normal market conditions, a minimum of 65% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

## Income policy

Any income allocated to the Share class from the Fund is reinvested.

## **Dealing Frequency**

Shares can be bought or sold daily in accordance with the Prospectus.

#### Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio.

## What are the risks and what could I get in return?

The assets of the Fund are held in safekeeping by its depositary. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

#### What are the costs?

#### Costs over Time

## How long should I hold it and can I take money out early?

## Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
