What is this product?

The Product is a share of the Sub-fund Wellington Strategic European Equity Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns.

The Fund will be actively managed, seeking to outperform the MSCI Europe Index (the "Index") investing predominately in a diversified portfolio of European domiciled companies that the Investment Manager believes will enjoy earnings and cash flow growth greater than average relative to the Index. The Index is a market capitalization weighted index that is designed to measure the equity market performance of the developed markets in Europe.

The Fund follows a bottom-up stock selection approach.

The Fund will invest in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts. The Fund may invest either directly or via derivatives.

While there are no restrictions on the Fund's ability to use derivatives for investment purposes (such as gaining exposure to a security), derivatives are mainly used to hedge (manage) risk.

The MSCI Europe Index ("the Index") serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of

the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The Fund will seek to support certain social characteristics by investing at least 60% of its net assets in companies with a social rating of 1-3, using a rating scale of 1-5, where 1 is the highest rating.

In addition, the Fund will not invest directly in the securities of any issuer identified as being principally engaged in the production of thermal coal (mining and power generation), oil sands extraction, nuclear warheads and missiles, and excludes controversial weapons.

During normal market conditions, a minimum of 80% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

This Share class will, via derivatives, seek to provide similar performance to the Fund in its base currency by limiting the impact of the movement of exchange rates between the currency of the Share class and the base currency of the Fund.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is EUR.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio.
