**What is this product?****Type**

The Product is a share of the Sub-fund Wellington Emerging Markets Opportunities Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

**Term**

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

**Objectives**

The Fund seeks long-term total returns primarily through capital appreciation.

The Fund will be actively managed, seeking to outperform the MSCI Emerging Markets Investable Market Index (the "Index") investing primarily in companies that are located and/or conduct substantial business activities in non-developed markets, including frontier markets (as defined by MSCI), and/or which conduct substantial business in those markets. The Investment Manager will look to the location of a company's assets, revenues and earnings in determining whether a company conducts substantial business activities in non-developed markets and the location of a company's stock exchange listing will have no bearing in this evaluation.

The Fund will invest, either directly or via derivatives, in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts.

The risk indicator assumes you keep the product for 5 years.

**Dealing Frequency**

Shares can be bought or sold weekly in accordance with the Prospectus. The base currency of the Fund is USD.

**Intended retail Investor**

The Fund is intended for professional investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

## What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing week. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing week. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
