What is this product?**Type**

The Product is a share of the Sub-fund Wellington Emerging Local Debt Advanced Beta Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns.

The Fund will be actively managed, investing primarily in a diversified portfolio of emerging market local currency-denominated debt securities and currency instruments. The Fund will generally be diversified by country, currency, sector and issuer, but may hold positions that are concentrated from time to time.

The Fund seeks a return that is broadly equivalent to overall market returns but with less risk. The Investment Manager considers overall market returns to be the return of a market capitalisation weighted index which favours higher weightings to the largest issuers of debt and whose exposure to a market is referred to as "Beta". The Fund provides exposure in an alternate manner, seeking to emphasise areas of the market that have demonstrated higher returns for the level of risk taken by investing in those areas, using a systematic risk-controlled approach. The Investment Manager calls this "Advanced Beta".

Investment in emerging markets local currency-denominated sovereign bonds creates an implicit short exposure in the base currency of the Fund and the movement of exchange rates between these currencies can impact the Fund's returns. The Fund will, via derivatives, seek to reduce this impact by diversifying this implicit short exposure across a basket of developed market currencies.

The Fund will invest, either directly or via derivatives, in bonds (fixed or floating rate) issued by government, sovereign, quasi-sovereign agency or supranational issuers and loan participation securities across multiple denominations and

countries. The Fund may actively manage its exposure to both emerging and developed currencies. Average credit quality is expected to be investment grade.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security). Derivatives will form a significant part of the strategy and will impact performance.

The JP Morgan Government Bond Index – Emerging Markets Global Diversified Index (the "Index") serves as a reference benchmark for performance comparison and as a proxy for the overall market returns for volatility measurement. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The Fund will seek to support certain environmental, social and governance (ESG) characteristics by maintaining an overall weighted average ESG score in excess of the Index, using an internal rating scale of 1-5, where 1 is the highest rating.

During normal market conditions, a minimum of 80% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

SC Share classes of the Fund will require an additional hedge, via derivatives, which seeks to ensure that the SC Share class has the intended exposure to the basket of developed market currencies.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

Intended retail Investor

The Fund is intended for professional investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
