What is this product?**Type**

The Product is a share of the Sub-fund Wellington Opportunistic Fixed Income Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns.

The Fund will be actively managed, seeking to achieve the objective primarily via long and short (synthetic) exposure in an unconstrained manner to a broad range of fixed income debt securities across multiple geographies, including securities with both investment grade and non-investment grade credit ratings.

The Investment Manager aims to enhance the Fund's value by investing in high conviction global fixed income ideas. Opportunities are looked for outside the core developed market government and investment grade corporate sectors focused on by most investors with the belief that market inefficiencies exist and can be exploited. Allocations are made to areas the Investment Manager considers misunderstood by other investors, for example where there is crisis, complacency or where structural change is going unrecognized, as well as to country selection, currency, duration, security selection or sector rotation strategies which are intended to capture short and medium term mispricing in the market.

The Fund is not restricted by geographies, credit ratings or investment styles and has the freedom to invest in areas such as global government, inflation-linked, corporate, securitized, high yield, bank loan, emerging markets and securities that are able to be converted in to equity securities.

The Fund will invest, either directly, via collective investment schemes (funds), or via derivatives, in bonds (fixed or floating rate) issued primarily by government, agency, quasi-sovereign, commercial and sub national government or supranational issuers (e.g. the International Bank for Reconstruction and Development), mortgage and other asset-backed securities, corporate bond securities. The Fund will generally be diversified by country, currency, sector and issuer, but may hold positions that are concentrated from time to time.

Investments will represent a broad credit spectrum, including up to 50% of the net assets of the Fund in below investment grade securities. These are considered to

be securities which have a relatively low credit rating. Currency is actively managed and may be denominated in a variety of currencies. There are no limitations on the credit quality of individual securities or currencies.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security, to create leverage and/or a short position). Derivatives will form a significant part of the strategy and will impact performance.

The Fund does not consider a benchmark during portfolio construction or for performance comparison purposes. However, the Bloomberg Barclays Global Aggregate Index hedged to USD (the "Index") is used as a proxy for the global market for volatility measurement.

The Fund promotes certain environmental, social and governance (ESG) characteristics by investing in issuers with ESG ratings and maintain an overall weighted average ESG rating which is at least 5% better than the Bloomberg Multiverse Index (the "Index"). In order to do this, the Investment manager assigns issuers an ESG Rating, based on Wellington Management's proprietary ratings framework, using a rating scale of 1-5, where 1 is the highest rating, and is used in the overall weighted average ESG rating calculation.

During normal market conditions, a minimum of 80% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

This Share class will, via derivatives, seek to provide similar performance to the Fund in its base currency by limiting the impact of the movement of exchange rates between the currency of the Share class and the base currency of the Fund.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

What are the risks and what could I get in return?

Risk Indicator

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
