### What is this product?

**Type**

The Product is a share of the Sub-fund Wellington Sustainable Multi-Asset Total Return Income Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

**Term**

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

**Objectives**

The Fund seeks a combination of long-term total returns with a regular income and to actively manage downside risk.

The Fund will be actively managed, investing in a broad array of global assets such as equities, government bonds, investment grade and high yield credit (such as corporate bonds) to support its aim to declare dividend income between 4%-8%, of its Net Asset Value in USD terms, per year. The Investment Manager believes that a consistent income combined with long term capital growth can be achieved through the active management of assets and market exposures within a disciplined risk control framework.

The Investment Manager focuses on four key areas when constructing the portfolio: diversification, differentiated implementation, dynamic asset allocation, and disciplined risk management.

The Fund seeks to invest in a diverse set of global asset classes. These allocations are actively managed to try and enhance returns, with a key focus on higher quality and more liquid assets.

The Fund will also seek to navigate evolving markets and opportunities via dynamic asset allocation, whilst a disciplined multi-layered risk management approach will aim to limit losses in the case of market weakness.

The Fund may invest, either directly or via derivatives, in shares and other securities with equity characteristics, comprising preferred stock, warrants, rights, depository receipts, and convertible securities; bonds (fixed or floating rate) issued by government, agency, supranational or corporate issuers; mortgage and other asset-backed securities and may also hold cash and cash equivalents in multiple currencies without restriction.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security, to create leverage

and/or a short position, efficient asset allocation). Derivatives will form a significant part of the strategy and will impact performance.

The Fund does not consider a benchmark during portfolio construction or for performance comparison purposes.

The Fund will seek to support certain environmental, social and governance (ESG) characteristics by ensuring that at least 65% of the Fund's net asset will be invested in companies with an ESG Rating 1-3, using an internal rating scale of 1-5, where 1 is the highest rating.

The Fund will also invest in issuers with ESG ratings to enable the Fund to maintain an overall weighted average ESG rating that is better than a rating of 3.

The Fund will invest at least 50% of the Fund's net assets in companies or issuers that are considered Sustainable Investments, which are companies or issuers that the Investment Manager believes contribute towards environmental or social stewardship, climate change, access to life essentials, economic development, inequality or other environmental and/or social challenges.

During normal market conditions, a minimum of 80% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

**Income policy**

The Share class will normally pay dividends from income monthly. The level of investment income generated by the Fund is not guaranteed and is dependent on market conditions. If the level of income is deemed insufficient, dividends may be paid from capital forgoing potential capital growth and eroding capital, potentially until all capital is depleted.

**Dealing Frequency**

Shares can be bought or sold daily in accordance with the Prospectus.

**Intended retail Investor**

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors. Investors in the Fund should be aware that, as set out in the Fund's Distribution Policy, dividends may be declared out of the capital of the Fund.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 5 years.

## What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## Costs over Time

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
