What is this product?

The Product is a share of the Sub-fund Wellington Focused European Equity Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns.

The Fund will be actively managed, seeking to outperform the MSCI Europe Index (the "Index") investing primarily in equity and equity related securities of companies domiciled or operating primarily in developed European markets. The Index is a market capitalisation weighted index that is designed to measure the equity market performance of the developed markets in Europe.

The Fund will generally invest in the securities of companies that the Investment Manager believes have been mispriced, usually due to an overreaction to a prolonged period of negative news and an overemphasis on recent results, which can lead to stocks being priced as though earnings will never improve. The Investment Manager will combine behavioral finance analysis, in which the sentiment around the company is assessed, along with management credibility and fundamental research, which looks at aspects such as the strength of a company's balance sheet, when making an investment decision.

The Fund will invest in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts. The Fund may invest either directly or via derivatives.

Derivatives may be used to hedge (manage) risk and for investment purposes (such as gaining exposure to a security).

The MSCI Europe Index ("the Index") serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The Fund will seek to support certain environmental characteristics by aiming to achieve net zero emissions by 2050 in alignment with the Paris Agreement, by investing a minimum of 40% of the Fund's NAV (excluding cash and cash equivalents) in companies which have established, or have committed to establish science-based targets, with this percentage increasing to a minimum of 70% by 2030, and 100% by 2035.

During normal market conditions, a minimum of 40% of the Fund's net assets will be aligned to the environmental characteristics of the Fund.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
