**You are about to purchase a product that is not simple and may be difficult to understand**

**What is this product?****Type**

The Product is a share of the Sub-fund Wellington US Dynamic Equity Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

**Term**

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

**Objectives**

The Fund seeks long-term total returns.

The Fund will combine an actively managed, seeking to outperform the S&P 500 Index (the "Index") by investing primarily in a concentrated portfolio of equity securities of US companies, together with broad U.S. market exposure as represented by the Index. The investment approach is based on the Investment Manager's belief that changes in earnings expectations drive stock prices and companies invested in will generally be those that demonstrate earning growth at accelerating or high levels, which means the Fund may have a natural growth style bias. The Index is a market capitalisation weighted Index of 500 stocks and is designed to measure the performance of the broader US economy. Index futures are used to seek to provide the investment results of the Index.

The allocation of the Fund between individual companies and broad market exposure will fluctuate depending on the number of companies the Investment Manager has identified with high conviction at any particular time. Companies will be selected based on the Investment Manager's evaluation of the market and company valuations, expected economic growth and individual company fundamentals. The broad market exposure portion of the fund will track the S&P 500 Index using index futures and a minimum of 10% of the fund will be composed of individual companies.

The portion of the fund which is invested in individual companies may be concentrated in a relatively small number of securities, industry sectors and/ or countries and as a result may be more volatile than more broadly diversified funds.

The Fund will invest in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts. The Fund may invest either directly or via derivatives.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security). Derivatives will form a significant part of the strategy and will impact performance.

The S&P 500 Index ("the Index") serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The currency of this Share class is different to the base currency of the Fund and so the performance of the Share class will be subject to the impact of the movement of the exchange rate between the currencies.

**Income policy**

Any income allocated to the Share class from the Fund is reinvested.

**Dealing Frequency**

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

**Intended retail Investor**

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio.

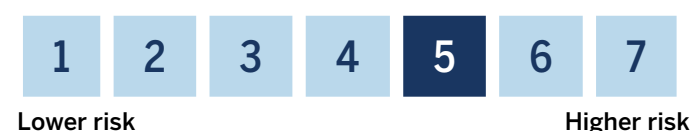

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## Performance Scenarios

## What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

## Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. ## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
