What is this product?

Type

UBS (Irl) Investor Selection plc is an umbrella investment company with segregated liability between sub-funds and with variable capital incorporated in Ireland as an undertaking for collective investment in transferable securities pursuant to the UCITS Regulations.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The Fund will seek to achieve its investment objective primarily through extensive investment in financial derivative instruments (FDIs) which reference the global currency markets. The FDIs used will be long and short currency futures and forward contracts (deliverable and non-deliverable), currency options (including the writing of options), which may result in the Fund being leveraged whereby the exposure of the Fund as a result of all positions held by it may exceed its net asset value. The Fund will also invest in short term securities (fixed and floating bonds issued by governments, supranational entities or corporations which are considered investment grade or above by the principal ratings agencies and money market instruments such as government treasury bills with less than 1 year to maturity), cash and Cash Equivalents. The actively managed Fund seeks to achieve a return in excess of the Reference Index which is the FTSE World Money Market Index Series - GBP 1 Month Euro Deposit. The Fund's investment universe is not constrained by the Reference Index. The base currency of the fund is GBP.

Sustainability risks are not systematically integrated on the basis of the investment strategy and the type of underlying investments. The return of the fund depends primarily on the development of global currency markets. To varying degrees, it will be a function of the following components: extent of convergence between market price and fair value, evolution of macro-economic fundamentals, and market risk perception.

The income in respect of an accumulation share class is not distributed but is retained in the Fund.

Intended retail investor

This fund applies to retail investors with an advanced financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Ireland) Limited is unable to pay out?

Morgan Bank (Ireland) plc as depositary of the Fund, which is responsible for the safekeeping of the assets of the Fund (the "Depositary"), there is a potential default risk if the assets of the Fund held with the Depositary are lost. However, such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund or to the investors of the Fund for the loss by the Depositary or one of its delegates of a financial instrument held in custody unless the Depositary is able to prove that the loss has arisen as a result of an external event beyond its reasonable control.

What are the costs?
