What is this product?

Type

UBS (CH) Money Market Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested

Ťhe recommended holding périod (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The primary investment objective of the actively managed sub-fund is to generate a long-term performance which matches that of the standard market indices for money market instruments denominated in US dollars (USD).

The sub-fund invests mainly in US dollar-denominated money market instruments of governments, other public sector entities or private issuers worldwide with first-class credit ratings. This sub-fund also invests in other investments permitted under the fund contract. The average

maturity of the securities in the portfolio may not exceed one year.

The sub-fund uses the benchmark FTSE USD 3M Eurodeposits as a reference for performance comparison. At times of high market volatility, the sub-fund's performance may deviate sharply from that of the benchmark.

The fund's return depends primarily on interest rates, issuer creditworthiness and interest income.

The income from this share class is reinvested (reinvestment).

This fund applies to retail investors with a basic financial understanding, The fund is aimed at preserving the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

Losses are not covered by any investor compensation or guarantee scheme. In addition, in relation to UBS Switzerland AG, which as the Fund's custodian is responsible for the safekeeping of its assets (the "Custodian"), there is a potential risk of default in the event that the Fund's assets held with the Custodian are lost. However, this risk of default is limited as the Custodian is required by law and regulation to segregate its own assets from the Fund's assets. The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control.
