### What is this product?

#### Type

UBS (CH) Money Market Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

Ťhe recommended holding périod (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The investment objective of the actively managed subfund is primarily to achieve long-term performance consistent with the development of the prevailing market indices for money market instruments denominated in euros (EUR).

The subfund invests primarily in money market instruments denominated in euros from countries, other public bodies or private borrowers worldwide that have been classified as first-class. Furthermore, this subfund invests in other investments permitted under the fund contract. The average maturity of the securities in the portfolio may not exceed 1 year.

The subfund uses the benchmark FTSE EUR 3M Eurodeposits as a reference for comparing performance. In times of high market volatility, the

performance of the subfund can deviate significantly from the benchmark.

The return of the fund depends primarily on the development of interest rates, the creditworthiness of issuers and interest income.

The income from this share class is reinvested (reinvestment).

This fund applies to retail investors with a basic financial understanding, The fund is aimed at preserving the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.

# What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

Losses are not covered by any investor compensation or guarantee scheme. In addition, in relation to UBS Switzerland AG, which as the Fund's custodian is responsible for the safekeeping of its assets (the "Custodian"), there is a potential risk of default in the event that the Fund's assets held with the Custodian are lost. However, this risk of default is limited as the Custodian is required by law and regulation to segregate its own assets from the Fund's assets. The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control.

### What are the costs?

#### Costs over time
