What is this product?

UBS (CH) Money Market Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

Objectives

The investment objective of the actively managed subfund is primarily to achieve long-term performance consistent with the development of the prevailing market indices for money market instruments denominated in Swiss francs (CHF).

The subfund invests primarily in money market instruments denominated in Swiss francs from countries, other public bodies or private borrowers worldwide that have been classified as first-class. Furthermore, this subfund invests in other investments permitted under the fund contract. The average maturity of the securities in the portfolio may not exceed 1 year. The actively managed subfund uses the benchmark FTSE CHF 3M Eurodeposits as a reference for comparing performance. In times of high

The return of the fund depends primarily on the development of interest rates, the creditworthiness of issuers and interest income. The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who seek to invest in a low-risk instrument. The fund is aimed at preserving the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.
