## What is this product?

### Type

UBS (Irl) ETF Plc is an umbrella investment company with variable capital and segregated liability between sub-funds incorporated in Ireland and authorised by the Central Bank as an Undertaking for Collective Investment in Transferable Securities under the UCITS Regulations. The fund is a UCITS ETF.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The Fund is passively managed and seeks to track the performance of the MSCI AC Asia ex Japan ESG Leaders Low Carbon Select 5% Issuer Capped Index (Net Return) (the Index). The Index is designed to measure the performance of large and mid-capitalization companies in Asia (excluding Japan) with high environmental, social and governance ("ESG") relative to their peers while excluding companies with negative social or environmental impact. This approach excludes at least 20% of the least well-rated securities as against the standard index universe (for further details please refer to the Description of the Index in the supplement). It is expected that the Fund's resulting ESG rating will be higher than the ESG rating of a fund tracking a standard index. At least 90% of the securities in the sub-fund, excluding cash, money market funds and derivatives have an ESG rating.

The Fund may also in exceptional circumstances hold securities which are not comprised in its Index, including, for example, securities in respect of which there has been an announcement or it is expected that they will shortly be included in the Index. The Fund may, for the purpose of reducing risk or reducing costs, use derivative instruments. The use of derivative instruments may multiply the gains or losses made by the Fund on given investment or on its investments generally.

The impact of currency fluctuations between any foreign currency to the Index currency is reduced by using a currency version of the Index to monitor hedge and investment ratios and to make an adjustment in the event that the ratios breach due to market movements. Hedging reduces the effect of the fluctuations in the exchange rate between the currencies of the equities that make up the Index and the Share Class currency.

This Fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The Fund will not enter into any securities lending.

Fund income is not paid out, but instead will be reinvested.

### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

### What happens if UBS Fund Management (Ireland) Limited is unable to pay out?

Losses are not covered by an investor compensation or guarantee scheme. Furthermore, with respect to State Street Custodial Services (Ireland) Limited as depositary of the Fund, which is responsible for the safekeeping of the assets of the Fund (the "Depositary"), there is a potential default risk if the assets of the Fund held with the Depositary are lost. However, such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary is liable to the Fund or to the investors of the Fund for the loss by the Depositary or one of its delegates of a financial instrument held in custody unless the Depositary is able to prove that the loss has arisen as a result of an external event beyond its reasonable control.

## What are the costs?
