# What is this product?

Focused SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

# Objectives

The actively managed fund invests predominantly in USD bonds issued by the International Bank for Reconstruction and Development "IBRD"). The average remaining term of the total portfolio is more than 4 years. This sub-fund has sustainable investment objectives. Due to their high interest rate sensitivity, the prices of the bonds react relatively strongly to changes in the interest rate level. The fund uses the benchmark Solactive Global Multilateral Developement Bank Bond USD 5-10 TR Index as a reference for portfolio construction, performance comparison and risk management.

The return of the fund depends primarily on the development of interest rates and creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged

against the currency of the fund.

# Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

#### Costs over time
