# What is this product?

## Туре

Focused SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

#### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The sub-fund invests in US government bonds denominated in USD. The sub-fund aims to track the benchmark index, Bloomberg US Treasury 1-5 Year Bond Index (Total Return) (Bloomberg code: LTR1TRUU). The sub-fund builds proportional exposure to the components of the benchmark index through direct investments. Rebalancing costs may apply when replicating index exposures through direct replication.
