What is this product?

Type

Focused SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment objective of the sub-fund is geared towards long-term asset growth. To this end, direct or indirect global exposure to equities is the main objective. The reference currency of the fund is CHF.

In order to implement the investment strategy, the portfolio manager may invest in various investment instruments such as individual shares, deposits, UCI- and UCITS-compliant equity and/or money market funds, UCITS-approved certificates and derivatives. The sub-funds may take strategic positions globally in equities and will develop leveraged exposure (both long and short) to equity markets of up to 500% through the use of derivatives at a tactical level. For liquidity reasons, the sub-funds may hold money market instruments, cash or cash equivalents.

The sub-fund is not restricted in its investments by a benchmark.

Sustainability risks are not systematically integrated due to the investment strategy and the nature of the underlying investments.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.
