What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Objectives

The investment objective is primarily to passively track the representative benchmark index SPI (TR) for the Swiss equity market and to achieve performance before deducting fees which is in line with that of the index.

This subfund invests primarily in equity securities of companies that are included in the benchmark index and in other investments permitted under the fund contract.

The fund's return depends primarily on the development of the stock markets and dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.
