What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested

Ťhe recommended holding périod (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The investment objective is primarily to passively track the representative benchmark index SPI 20® (TR) for the Swiss equity market and to achieve performance before deducting fees which is in line with that of the index.

This subfund invests primarily in equity securities of companies that are included in the benchmark index and in other investments permitted under the fund contract.

The fund's return depends primarily on the development of the stock markets and dividend payments.

The income from this share class is reinvested (reinvestment).

This fund applies to professionally managed discretionary mandates for retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
