What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested Ťhe recommended holding périod (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The primary investment objective of this sub-fund is to passively replicate the representative benchmark FTSE Climate Risk-Adjusted World Government Bond Index (CHF hedged) for global bonds that are hedged against the Swiss franc, and to achieve a performance in line with that of the index. The benchmark takes into account investment risks relating to climate change and shifts the corresponding weighting of the issuers relative to the parent index. This subfund invests mainly in bonds and/or funds holding securities of borrowers in the benchmark and in other investments permitted under the fund contract. The fund largely hedges foreign currencies against the fund's reference currency, CHF. The fund's return depends primarily on interest rates, issuer creditworthiness and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

What are the costs?

Costs over time
