What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested. Ťhe recommended holding périod (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The primary investment objective is to passively replicate the representative benchmark SBI® Domestic AAA-BBB 1-5 years (TR) for mediumterm bonds of Swiss issuers denominated in Swiss francs (CHF) and to achieve a performance gross of fees in line with that of the index This sub-fund invests mainly in debt securities of borrowers in the benchmark and in other investments permitted under the fund contract. The fund's return depends primarily on interest rates, issuer creditworthiness and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment).

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired
