You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment objective is primarily to passively replicate the benchmark index representative of the Pacific equity market, MSCI Pacific ex Japan (net div. reinv.), and to achieve a performance, before fees, in line with that of the index.

This sub-fund invests primarily in equity securities of companies included in the benchmark index and in other investments permitted under the fund contract.

The fund's return is primarily dependent on equity market performance, currency fluctuations and dividend distributions.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
