## What is this product?

### Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

UBS Asset Management categorises this sub-fund as a rule-based climate-aware strategy fund focusing on net zero. This subfund promotes climate-friendly characteristics as well as sustainable characteristics in general. The primary investment objective of this sub-fund is to generate long-term performance in line with the performance of market-wide indices of global equities (ex Switzerland). The subfund follows a rule-based investment approach that takes both quantitative and qualitative criteria into account when determining the weighting of investments.

The aim of the rule-based approach is to take investment risks resulting from the consequences of climate change into account in the weighting of its investments. The sub-fund uses the benchmark as a reference point when compiling the portfolio: it predominantly invests in companies that are included in the benchmark, meaning that an array of climate, sustainability and risk criteria are taken into consideration when assembling the portfolio. The indicators used to identify the possible investment universe predominantly measure the expected contribution of companies to climate change, where the focus is on reducing the impacts of climate change risk by limiting greenhouse gas emissions and taking them into consideration. The following sustainability objectives relative to the benchmark are taken into consideration: -lower weighted average Scope 1, 2 and 3 (revenue-based) carbon intensity -lower exposure to coal as an energy source -lower exposure to fossil fuel reserves (coal, oil and gas) -higher exposure to renewable energy and climate technology -a higher ESG score (measured using the UBS ESG Consensus Score) -a higher social score -a higher governance score.

The return of the fund mainly depends on the performance of the equity markets, currency fluctuations and dividend payments.

The income from this share class is reinvested (reinvestment).

### Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

### What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
