What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

UBS Asset Management categorises this sub-fund as a rule-based climate-aware strategy fund focusing on net zero. This sub-fund promotes characteristics which are climate-friendly as well as sustainable in general. The primary investment objective of this sub-fund is to generate long-term performance in line with that of global corporate bonds that are hedged against the Swiss franc. The sub-fund follows a rule-based investment approach that takes quantitative and qualitative criteria into account. The aim of the rule-based approach is to take investment risks arising from the consequences of climate change into account in the weighting of its investments. The sub-fund uses the benchmark as a reference point when compiling the portfolio by investing predominantly in issuers included in the benchmark, which therefore means that an array of climate, sustainability and risk criteria are taken into consideration when putting together a portfolio. The indicators used to identify the possible investment universe predominantly measure the expected contribution of issuers to climate change, where the focus is on reducing the impacts of climate change risk by limiting greenhouse gas emissions and taking them into consideration. The following sustainability objectives relative to the benchmark are taken into consideration: – lower weighted average carbon intensity of Scope 1 and 2, as well as Scope 3 (revenue-based); – lower exposure to coal power; – lower exposure to fossil fuel reserves (coal and oil & gas); – higher exposure to renewable energies and climate technologies; – a higher Green Opportunity Factor Score. The fund does not carry out any securities lending.

The fund's return depends mainly on the performance of interest rates, the creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.
