What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Objectives

The investment objective of this sub-fund is primarily to passively replicate the representative benchmark index SPI® ESG (TR) for the Swiss equity market (benchmark) and to achieve a performance that corresponds to the performance of this index. The benchmark index measures the performance of Swiss equities, taking into account environmental, social and governance factors. These factors are quantified using a framework and sustainability data provided by Inrate (an independent Swiss sustainability rating agency). The benchmark index is composed of components of the SPI that have a rating of at least C+ on an ESG rating scale of no higher than A+ to D- and generate less than 5% of their turnover in controversial activities.

The fund does not engage in securities lending activities.

The fund's return depends primarily on the performance of the equity markets and dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
