What is this product?

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The primary investment objective of this sub-fund is to passively replicate the representative benchmark SBI® ESG Domestic AAA-BBB 1-5 (TR) index for medium-term bonds denominated in Swiss francs (CHF), and to achieve a performance in line with that of the index. The reference index measures the development of bonds denominated in Swiss francs (CHF) while taking environmental, social and governance factors into consideration. These factors are quantified using a framework provided by Inrate (an independent Swiss sustainability reporting agency) and corresponding sustainability data. The benchmark is composed of those elements of the SBI Domestic AAA-BBB that have a rating of at least C+ on an ESG rating scale from A+ (highest) to D- and that generate less than 5% of their revenue from controversial activities. The fund does not enter into any securities lending.

The fund's return depends primarily on interest rates, issuer creditworthiness and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.
