What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

UBS Asset Management categorises this subfund as a rule-based climate aware strategic fund. This subfund promotes climate-friendly characteristics as well as sustainable characteristics in general. The investment objective of this subfund is primarily to generate long-term performance in line with that of market-wide indexes of Swiss equity investments and to have a sustainability profile exceeding that of the Swiss Performance Index (TR) at the time of the index adjustment. The subfund follows a rule-based investment approach that takes both quantitative and qualitative criteria into account when determining the weighting of investments. The aim of the rule-based approach is to take investment risks resulting from the consequences of climate change into account in the weighting of its investments. The subfund uses the benchmark as a reference point when compiling the portfolio by predominantly investing in companies included in the benchmark, which therefore means that an array of climate, sustainability and risk criteria are taken into consideration when putting together a portfolio. The indicators used to identify the possible investment universe predominantly measure the expected contribution of companies to climate change, where the focus is on reducing the impacts of climate change risk by limiting greenhouse gas emissions and taking them into consideration. The current sustainability objectives take the following aspects into consideration relative to the benchmark: – lower weighted average Scope 1 and 2 carbon intensity, with Scope 3 to be gradually introduced by 2030 at the latest – a higher ESG score – a higher social score – a higher governance score and – a higher green opportunity factor score. The sub-fund also has a focus on net zero.

The fund's return depends primarily on the performance of the equity markets and dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
