What is this product?

Type

UBS (CH) Investment Fund is a contractually-based umbrella fund under Swiss law of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested

Ťhe recommended holding périod (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

UBS Asset Management classifies this investment fund as a Sustainability Focus Fund, which promotes ecological and/or social characteristics. The primary investment objective of this sub-fund is to have a superior sustainability profile to that of its benchmark. The sub-fund also seeks to achieve a better return than the representative SPI (TR) benchmark for Swiss equities over a full market cycle. The sub-fund invests taking into consideration the sustainability criteria listed below, mainly in companies that have a suitable sustainability

profile. These are companies that, compared with other companies, show good commitment to environmental and social matters and have corporate governance that is sufficiently good or better than other companies. Data from and analysis by recognised external data providers are used for the sustainability assessment. The analysis of sustainability/ESG criteria can include the following aspects: the environment, employees and suppliers, buyers and customers and management.

The fund's return depends primarily on the performance of the equity markets and dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to professionally managed discretionary mandates for retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

What are the costs?

Costs over time
