# What is this product?

#### Type

Global Opportunities Access is an undertaking for collective investment in transferable securities (UCITS) incorporated in the legal form of an investment company with variable capital (SICAV) under Part I of the Luxembourg 2010 Law on undertakings for collective investment.

#### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The investment objective of the actively managed sub-fund is moderate appreciation of assets in the long term by seeking indirect exposure to primarily corporate bonds. The reference currency of the sub-fund is USD.

In order to implement the investment strategy, the Portfolio Manager may invest in different types of investment instruments such as deposits, shares or units of UCITS or other UCI funds, UCITS eligible certificates, and derivative instruments. The Portfolio Manager will not invest in single bonds

The assets of the sub-fund are invested following the principle of risk diversification. The sub-fund is actively managed and is not constrained by a benchmark index. A benchmark index is not used for performance comparison purposes.

For liquidity purposes, the sub-fund may hold money market instruments, cash or cash equivalents.

Sustainability risks are not systematically integrated on the basis of the investment strategy and the type of underlying investments.

# What happens if UBS Asset Management (Europe) S.A. is unable to pay out?
