What is this product?

Type

BKB Anlagelösung is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The objective of this investment fund is to generate real long-term capital growth through capital gains supplemented by possible interest and dividend income. The sustainable investment solution incorporates environmental and social criteria into the investment decision in addition to traditional financial indicators. The fund management invests the fund assets mainly in units of other collective investment schemes. The assets are predominantly invested in investments denominated in Swiss francs. The investment is made at a minimum of 70% in collective investment schemes which invest their assets mainly in equity securities and rights of companies. No benchmark index is used. The fund manager invests at its own discretion but within the specified investment restrictions.

The fund's return depends primarily on the performance of the equity markets and dividend payments.

The fund's income is added annually to the fund's assets for reinvestment (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired subject to a test of the investor's financial knowledge and experience.

What are the risks and what could I get in return?

Indicator

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

What are the costs?

Costs over time
