What is this product?

Type

The product is a unit of the fund GAM Swiss Sustainable Companies (the "Fund"), a contractual investment fund of the "other funds for traditional investments" category.

Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

Objectives

Investment Objective

The aim of the fund is to achieve long-term capital growth. For this purpose, the Fund invests in companies located in Switzerland that take into account sustainability issues within the scope of the business operations. Sustainability is defined as the application of the principles of renewability, circularity, networking, incorporating locations, multifunctionality and compliance for the sustainable development of a company.

Investment Policy

The Fund invests at least 2/3 of its assets in shares of smaller and medium-sized companies (SMEs) that are domiciled or predominantly active in Switzerland, or are represented in a Swiss index.

The Fund's benchmark is the Swiss Performance Index (SPI) Extra GD, which represents the Swiss equity market for small and medium-sized companies. The Fund is actively managed and aims to outperform the benchmark index over the long term. In the selection and weighting of Fund investments, the Fund is independent of the benchmark index.

Share Class Policy:

The Fund has several share classes. These may differ with regard to fees, minimum investment, use of revenues and investor qualification.

Income in the share class is distributed annually to investors.

Processing of subscription and redemption orders

Investors may buy or sell the Fund on any banking day in Zurich.

Intended retail Investor

This Fund is aimed at retail and professional clients and eligible counterparties, who are seeking capital accumulation across categories and have a medium-term investment horizon. This Fund is aimed at investors with basic knowledge or experience of financial products. The investor is prepared to bear financial losses and does not require any capital guarantees.

What are the risks and what could I get in return?

Risk Indicator

The risk indicator assumes you keep the product for 5 years.

What happens if GAM Investment Management (Switzerland) AG is unable to pay out?

For your protection the company's assets are held separately with the custodian, so the Fund's ability to pay out would not be affected by the insolvency of the Fund Management Company. If the Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. The assets and liabilities of the Fund are segregated from other sub-funds in the GAM Swiss Sustainable Companies, subject to the provisions of Swiss law. This document describes a share class of a sub-fund of the GAM Swiss Sustainable Companies. Subject to the conditions set down in the prospectus of the GAM Swiss Sustainable Companies, you are entitled to switch from one share class to another, either in the Fund or in another sub-fund of the GAM Swiss Sustainable Companies. What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
