### WHAT IS THIS PRODUCT?

#### Type:

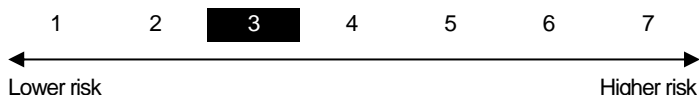
#### Objectives:

The Fund is a financial product that promotes environmental and/or social characteristics pursuant to Article 8 of the Sustainable Finance Disclosure Regulation. The Fund aims to generate income and capital appreciation by investing in currencies and government bonds. A majority of the bonds held will be inflation-indexed ("real return"), meaning that the interest paid on these bonds is adjusted to compensate for the impact of inflation. The Fund is actively managed against the \*Bloomberg World Government Inflation-Linked Bond Index (the "benchmark"). The Fund can invest in bonds (which may include inflation linked bonds) issued by governments, government agencies and supra-national agencies (such as the World Bank), irrespective of whether such bonds are included in the benchmark. The Fund will tend to purchase bonds with characteristics similar to those in the benchmark however, the investment strategy can lead to significant deviation from the benchmark in terms of country and currency weightings and duration, which can cause the return of the Fund to differ significantly from that of the benchmark. The Fund can invest in currencies using contracts on the spot and forward market, such as forward currency contracts (contracts to buy or sell a currency at a specified future time at an agreed price). Up to 20% of investments made by the Fund may be of lower quality than investment grade (for example, emerging market investments). The choice of assets is guided by value. You should be aware that, if you decide to purchase Shares, you will be relying on the expertise of the Fund's investment manager to select investments for the Fund. The possible gains and losses of the Fund may be increased through the use of financial derivative instruments such as forward currency contracts which are used by the Fund's investment manager to counteract currency exposure. These possible losses cannot exceed 100% of the value of the Fund. #### Intended Retail Investor:

The product is intended for investors for which an investment in a fund does not constitute a complete investment programme and who are looking to diversify their investments through exposure to developed and emerging market government and government related bonds and currencies, and that fully understand and are willing to assume the risks involved in the Fund's investment programme including an acceptance of moderate risk tolerance. This product is intended for investors who seek returns from both income and moderate capital appreciation; and who are willing to adopt a medium to long-term approach to their investment strategy, investing for a minimum of three years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 3 years.

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
